**DRIVING SAFETY COURSE (DEFENSIVE DRIVING) INFORMATION**

READ INSTRUCTIONS CAREFULLY – Failure to do so may void your request.

Under Sec. 143A-2, RMVL, the Court shall defer proceedings and allow you 90 days to present evidence that subsequent to the alleged offense, you have successfully completed a DRIVING SAFETY COURSE approved by the Texas Department of Public Safety, **IF**:

1. You were NOT charged with the offense of Speeding 25 MPH or more over the posted speed limit, Hit and Run, Involved in an accident with damage to a vehicle, Fleeing, or Reckless driving.
2. You have NOT taken a Driving Safety Course for dismissal of a traffic citation within the last 12 months and submit the sworn affidavit stating so.
3. **On or before** your appearance date, you enter a plea of NOLO CONTENDERE or GUILTY and present to the court a written request to take the course.
4. You must have a valid Texas Driver's License or Permit.
5. You must have current automobile insurance.
6. You pay \$110.00 in cash (Exact Amount), Check or Money Order to the Court or if you wish to make a credit/debit card payment, please contact the court.

**You must provide the Court the following within 90 days:**

- Copy of your Driver's License
- Proof of Insurance
- Sworn Affidavit
- Completion Certificate for the DSC

When the Court has accepted the Certificate and all documents have been submitted to the Court, the charge will be dismissed. **However, IF YOU FAIL TO COMPLY WITHIN 90 DAYS, you will be responsible for additional fines and fees and a warrant may be issued for you arrest.**
