- You <u>must</u> provide the court with 1 original, 1 copy for your records, and 1 copy per defendant (if 2 defendants will be served, then you must provide a copy for each of them) of the petition and all documents supporting the petition. <u>Evidence for your case should be provided at the time of filing and a copy of everything filed with the Court should also be provided for the other parties in the case. Failure to provide a copy for all parties in suit will result in additional charges for copies made by the Court.</u>
- Check the status of your case on our website under <u>Judicial Records Search</u>. Once a defendant has been served, they are allowed 15 days to answer the Court. If they do not answer the Court in the time allotted, you may move forward with your case.
- All hearings for JP1 are remote Zoom hearings except for Jury Trials. Instructions for Zoom will be provided in your hearing notice.
- The Constable does NOT serve Out of County Citations. Please notify the clerk if the Party you are suing will not be served in Angelina County.
