On behalf of Angelina County Waste Management Center (ACWMC) and in accordance with 30 TAC §305.70(k)(3), Hydrex Environmental (Hydrex), hereby submits this request for a Municipal Solid Waste Permit Modification to the existing permit at the above-referenced site. Specifically, the modification pertains to the Site Development Plan, Attachment 14, Landfill Gas Management Plan.

In response to methane exceedances reported for site monitoring probes, the existing landfill gas collection and control system (GCCS) was expanded to increase landfill gas recovery efficiency and mitigate the potential for landfill gas migration beyond the existing permitted waste footprint on the east and west sides of Tract 1 of ACWMC. The expansion has resulted in the connection of the existing GCCS to six newly-installed landfill gas extraction wells with associated piping for transfer to the existing blower/flare system. This expansion is illustrated on the attached Figure GMP-A-5. Additional landfill gas recovery, achieved by connection of the GCCS to leachate collection and recovery sidewall riser pipes, is also proposed as part of this permit modification.

Based on previous TCEQ correspondence dated February 10 and 13, 2017 (Tracking No. 2122965 and 21303199, respectively), public notice is required for the GCCS expansion. We trust the submittal is sufficient to affect the proposed revision to Permit No. MSW-2105A.
