Notice is hereby given of a public nonjudicial foreclosure sale.

1. Property To Be Sold. The property to be sold is described as follows:

BEING all those certain lots, tracts or parcels of land out of the Thomas Banks Survey, Abstract No. 304 in Angelina County, Texas, and being more particularly described in Exhibit "A" and Exhibit "B" attached hereto and made a part hereof for any and all purposes as though copied in full herein.

2. Date, Time, and Place of Sale. The sale is scheduled to be held at the following date, time, and place:

Date: May 3, 2016

Time: The sale shall begin no earlier than 1:00 P.M. or no later than three hours thereafter. The sale shall be completed by no later than 4:00 P.M.

Place: Angelina County Courthouse Annex Building in Lufkin, Texas, at the following location:

Angelina County Commissioner's Courtroom located at the Angelina County Courthouse Annex Building, 606 East Lufkin Avenue, Lufkin, Angelina County, Texas. In the event that early voting or an election is going on in the Commissioner's Courtroom, the sale will take place on the front steps of the Angelina County Courthouse Annex. If early voting is going on and the weather is bad, the sale will take place in the Angelina County Courthouse Annex foyer or any other location designated by the commissioners court of Angelina County.

The deed of trust permits the beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the trustee or substitute trustee under the deed of trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. Such reposting or refiled may be after the date originally scheduled for this sale.

3. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay cash on the day the property is sold.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but

prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.

4. Type of Sale. The sale is a nonjudicial deed of trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the deed of trust executed by Lewis Qualls. The deed of trust is dated December 7, 2007, and is recorded in the office of the County Clerk of Angelina County, Texas, in Document Number 242688, of the Real Property Records of Angelina County, Texas.

5. Obligations Secured. The deed of trust provides that it secures the payment of the indebtedness and obligations therein described (collectively the "Obligations") including but not limited to (1) the promissory note in the original principal amount of \$200,000.00 executed by Lewis Qualls payable to the order of Pamala S. Qualls White, (2) any and all renewals and extensions of the note; and (3) Pamala S. Qualls, is the current owner and holder of the Obligations and is the beneficiary under the deed of trust.

Bohlsen to Lewis Qualls dated May 7, 1976 and recorded in Volume 439 on Page 27 of the Deed Records of Angelina County, Texas, and an interior corner of that certain 22.70 acre tract described in a deed from Donald Ray Luce, et ux to Howard Kevin Malone, et ux dated June 30, 1994 and recorded in Volume 973 on Page 581 of the Real Property Records of Angelina County, Texas, a rod found for corner (at a fence corner);

THENCE N 38° 53' 31" E (called N 36° E) with the Northwest boundary line of the said 46 acre tract and the Southeast boundary line of the said 68.13 acre tract, at 1388.08 feet (called 1388.89 feet) a North corner of the said 46 acre tract and an interior ell corner of the said 68.13 acre tract, a pine knot set for corner (near a fence corner) witnessed by a 8" Sweet Gum (old) bearing S 22° E 18.9 feet;

THENCE S 42° 45' 31" E (called S 45° E) with the Northeast boundary line of the said 46 acre tract and the Southwest boundary line of the said 68.13 acre tract, at 1247.39 feet the Southeast corner of the said 68.13 acre tract, a U.S.C.E. monument found for corner in the fee (lake) line of the Sam Rayburn Reservoir (Volume 266, Page 56);
