BEGINNING S 44° 57' W 90.00 feet from the East corner of the aforesaid referred to 1.74 acre tract, a 1/2" iron pin set for corner on the Southeast boundary line of same and being on the Northwest margin line of an oiled road;

BEGINNING at the East corner of the aforesaid referred to 1.74 acre tract, an iron pipe found under pavement at the intersection of the Northwest margin line of an oiled road and the Southwest margin line of another oiled road;

THENCE S 44° 57' W, with the Southeast boundary line of the said 1.74 acre tract and the Northwest margin line of the first mentioned oiled road, at 90.00 feet, a 1/2" iron pin set for corner;

THENCE N 45° 26' W, at 121.00 feet, a 1/2" iron pin set for corner;
