We have completed the technical review of the modification request dated October 17, 2006, and the revisions dated January 11, 2007, February 26, 2007, April 27, 2007, and June 18, 2007, requesting to update the Site Operating Plan to comply with Title 30 Texas Administrative Code (30 TAC) Chapter 330 Subchapter D (effective March 27, 2006). The information presented is technically sufficient for a permit modification, and we have prepared a draft modification.

1. Please mail notice in accordance with 30 TAC §305.70(i) and 30 TAC §39.106. The text of the notice must comply with 30 TAC §§39.411(b)(1), (2), (3), (6), (7), (9), and (12). Notice must be mailed to all persons listed in 30 TAC §39.413. We have provided an example for your convenience.
2. Please state in the notice the requirement that written comment by the public must be received by the Office of the Chief Clerk within 23 days from the date notice was mailed.
