


RECONCILIATION OF TOTAL VOTES CAST AT EACH POLLING LOCATION

EARLY VOTING CITY OF LUFKIN PARKS AND RECREATION

Discrepancy:

23 MORE VOTER WHO VOTED THAT BALLOTS CAST

Reason for Discrepancy:

THE ELECTION JUDGE LOGIN IN TO THE WRONG POLLING
LOCATION ON ELECTION DAY. IT ADDED 23 MORE VOTERS THAN
VOTES CAST.

Polling Location:

ED CITY OF LUFKIN PARKS & RECREATION

Discrepancy:

23 MORE BALLOT CAST THAN VOTERS

Reason for Discrepancy:

ELECTION JUDGES SIGNED INTO THE EARLY VOTING POLLING
PLACE INSTEAD OF ELECTION DAY. THEY CORRECTED IT BUT
23 VOTERS HAD ALREADY CHECKED IN CAUSING THE POLLBOOK
TO BE LESS VOTERS THAT BALLOTS CAST.

ATTACHMENT B

Polling Location: EV CLAWSON ASSEMBLY OF GOD CHURCH

Discrepancy: 1 MORE VOTED THAN BALLOTS CAST

Reason for Discrepancy: A VOTER CHECKED IN AND WENT TO VOTE. WHEN THE ELECTION JUDGE TOLD HIM HE HAD TO BUT HIS PHONE AWAY HE GOT MAD LEFT THE WITHOUT VOTING. JUDGE DID NOT CANCEL HIM ON THE POLLBOOK.VOTER

Polling Location: EV ANGELINA COUNTY ZAVALLA SUB COURTHOUSE

Discrepancy: 1 MORE VOTER THAT BALLOTS CAST

Reason for Discrepancy: VOTER VOTED BUT THE DS200 WOULD NOT TAKE HER BALLOT. SHE DID NOT WANT ANOTHER BALLOT OR DIDN'T LET THEM PUT IT IN THE EMERGENCY SLOT OR REISSUE OR PROVISIONAL. SHE DID NOT WANT TO GO THROUGH THE TROUBLE.

Polling Location: EV ANGELINA COUNTY ELECTIONS ADMINISTRATION

Discrepancy: 25 MORE VOTES CAST THAN VOTERS ON THE POLLBOOK

Reason for Discrepancy: WE HAD 25 LIMITED BALLOTS. MAKING THE DIFFERENCE IN
VOTES CAST TO VOTER VOTED.

Polling Location: KURTH MEMORIAL LIBRARY

Discrepancy: 1 MORE VOTER THAT BALLOTS CAST

Reason for Discrepancy: VOTER CHECKED IN AND LOOKED AT THE BALLOT AND DID
NOT WANT TO VOTE. HE DID NOT PUT IT IN THE ds200 BLANK
THE ELECTION JUDGE DID NOT CANCEL HIM FOR THE POLLBOOK.

Reason for Discrepancy:

THEY HAD TROUBLE WITH THE PRINTER RE CONNECTING TO THE

CARDS SO THEY MOVED TO THE ONE WORKING AND IT COUNTED
A VOTER ON THE ONE LOCKING UP WHEN IT UNLOCKED.

THE CLERK CHECKED THE VOTER IN AND DID NOT REALIZE IT PROCESSED AND TOLD THE VOTER HE HAD ALREADY VOTED A FEW MINUTES AGO. THEY HAD HIM WAIT AROUND AND VOTE A PROVISIONAL BALLOT. VOTER CHECKED IN BUT DIDN'T HAVE TIME TO VOTE BALLOT SO HE LEFT AND IT WAS SPOILED. CLECK DID NOT CANCEL HIM
