### **Application / Petition for Occupational Driver's License**

You may file a petition for Occupational License in this Court if the suspension is not conviction based. Refer to the OCL Frequently Asked Questions on our website <a href="www.AngelinaCounty.net">www.AngelinaCounty.net</a> to see if you are eligible for an OCL.

A filing fee of \$46.00 is due to the Court when you file the petition. *IF* the Occupational License is GRANTED, you will need to bring \$20.00 (\$10.00 per certified copy X 2 copies) to the Court and a SEPARATE money order made payable to DPS in the amount of \$10 (for 1 year) or \$20 (for 2 years). The Court will mail a certified copy of the Order and the Money Order to DPS.

We accept cash (for the exact amount), check, or money order for payments to the Court.
