## NOTICE

Read over your paperwork carefully and complete all forms included in the packet. If you fail to provide ALL of the information required, the case may be dismissed. It is best to have an Attorney, but if you choose to represent yourself, you are responsible for your case.

**NOTICE:** Effective January 1, 2022, a civil filing fee and transcript fee are required to file an Appeal in Justice Courts.

Filing Fee: \$54.00 + Transcript Fee: \$10.00 = **\$64.00**

- The Judge and Clerks are prohibited from providing legal advice or assisting in filling out forms.
- Please refer to [www.AngelinaCounty.net](http://www.AngelinaCounty.net) to determine the office's hours of operation, hours they accept civil filings, and the methods of payment accepted.
- If you are a Pro Se Litigant (Not represented by an Attorney), it is your responsibility to be familiar with the laws that govern Appeals. A copy of the **Texas Rules for Civil Procedure (Sec. 506 covers appeals for small claims and debt claim cases. Sec. 510 covers appeals for evictions)** is provided in our office for your review during normal business hours. You may also access the links on our website [www.AngelinaCounty.net](http://www.AngelinaCounty.net) under Justice of the Peace, Civil Court page. **The Court CANNOT assist you with your case. Utilize the resources provided.**
- You **must** provide the court with the original, and a true and correct copy to the opposite party. Forms are located on our website under Justice of the Peace, Civil Court Forms.
- Appeal Bonds must be approved by the Court.
- Perfected appeals will be sent to County Clerk's office of Angelina County and will be heard in County Court at Law.
