**NOTICE:** Effective January 1, 2022, a civil filing fee and transcript fee are required to file an Appeal in Justice Courts. Filing Fee: \$54.00 + Transcript Fee: \$10.00 = **\$64.00**

- If you are a Pro Se Litigant (Not represented by an Attorney), it is your responsibility to be familiar with the laws that govern Appeals. Sec. 510 covers appeals for evictions) is provided in our office for your review during normal business hours. Utilize the resources provided.

- Perfected appeals will be sent to County Clerk's office of Angelina County and will be heard in County Court at Law.
