REQUEST FOR DRIVER SAFETY COURSE INSTRUCTIONS

You must be approved by the court before you take the Drivers Safety Course

The following MUST be returned to the Court before DSC will be granted.

- Request for Driver Safety Course
- Affidavit (Stating that you have NOT taken DSC for dismissal of a ticket in last 12 months)
- Type 3A Driving Record (can be obtained from DPS website)
- Copy of Driver License
- Copy of current Proof of Insurance

****Please contact the Court in which your ticket has been filed to inquire about acceptable methods for returning documents****

Once the request and supporting documents have been received, the Court will review.

If you are approved for Driver Safety Course, you will receive an Order Granting Driver Safety Course with payment instructions. Payment of \$140.00 will be due immediately. You will then have 90 days from the date of the Order Granting Driver Safety Course to complete the course and return the signed certificate of completion to the Court.

READ INSTRUCTIONS CAREFULLY - Failure to do so will void your request.

CCP 45.0511 (A)(1) – (3), the Court shall defer proceedings and allow you 90 days to present evidence that subsequent to the alleged offense, you have successfully completed a DRIVING SAFETY COURSE approved by the Texas Department of Public Safety, **If**;

1. You have NOT taken a Driver Safety Course for dismissal of a traffic citation within the last 12 months and submit the sworn affidavit stating so.
2. You must have a valid Texas Driver License or Permit.
3. You must have current automobile insurance.
4. Do NOT hold a Commercial Diver License (CDL)

You are NOT eligible for DSC if;

You were charged with the offense of;

- Speeding 25 MPH or more over the posted speed limit

- Driving a speed of 95 miles per hour or higher
- Passing a School Bus
- Moving Violation in Construction Zone with Workers Present
- Hit and Run (Leaving the Scene of an Accident with damage to a vehicle)
- Fleeing (Failure to give info/render aid)

I waive my right to a trial by jury, and request Driver Safety Course.

As conditions of Driver Safety Course, I understand that the Court will impose cost of court and DSC Administrative fees totaling **\$140.00** and the final disposition will be dismissed upon completion of Driver Safety Course (DSC).

1. Defendant shall not receive any additional violations.
2. Defendant will pay \$140.00 in full immediately upon receiving Order Granting DSC.
3. Defendant will complete state approved DSC Course within 90 days from date the Order Granting DSC is signed.
4. Defendant will return to the Court the Driver Safety Course Completion Certificate within 90 days from the date the Order Granting DSC is signed.

Upon completion of ALL requirements of Driver Safety Course, the case will be dismissed.

Failure to complete the identified requirements within the deferral period will result in the imposition of a final judgment and conviction and original fine.
