## DRIVING SAFETY COURSE (DEFENSIVE DRIVING) INFORMATION

**READ INSTRUCTIONS CAREFULLY** - Failure to do so will void your request. CCP 45.0511 (A)(1) – (3), the Court shall defer proceedings and allow you 90 days to present evidence that subsequent to the alleged offense, you have successfully completed a DRIVING SAFETY COURSE approved by the Texas Department of Public Safety, **IF**:

- 1. You have NOT taken a Driving Safety Course for dismissal of a traffic citation within the last 12 months and submit the sworn affidavit stating so.
- 2. You must have a valid Texas Driver's License or Permit.
- 3. You must have current automobile insurance.

#### You are NOT eligible for DSC if;

You were charged with the offense of;

- Speeding 25 MPH or more over the posted speed limit
- Driving a speed of 95 miles per hour or higher
- Passing a School Bus
- Moving Violation in Construction Zone with Workers Present
- Hit and Run (Leaving the Scene of an Accident with damage to a vehicle)
- Fleeing (Failure to give info/render aid)
- Hold a Commercial Drivers License (CDL).
