1. Judge Don Lymbery called the meeting to order at 10:00 A.M. with all the members present.
2. Opening prayer by Rev. David Hunt, Eastview United Pentecostal Church, Lufkin, Texas.

5. Bobby Cheshire made a motion to approve the Commissioners' Court Minutes for March 23, 2021. Terry Pitts seconded the motion.

Terry Pitts made a motion to approve the proposed modification to Angelina County's Personnel Policy on Workers Compensation-Angelina County, for up to sixty work days from the date of accident, will also pay an employee receiving workers compensation payments the difference between the employee's regular gross salary and the amount of the employee's workers compensation check, so that the employee's total net (take home) pay for the period will be approximately the same as the employee's net pay prior to the accident. Following the expiration of sixty work days (12 calendar weeks) from the date of the accident, the employee will receive only the workers compensation check and will no longer receive a county check.
