NOTICE OF FORECLOSURE SALE

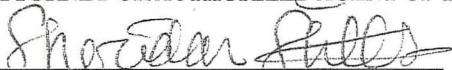

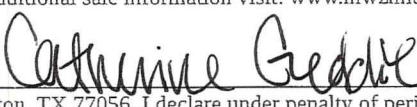
