

Expunctions

In accordance with Texas Code of Criminal Procedure Article 55A.253(c) the following is a list of agencies involved in the expunction process. **This list is not all-inclusive.** Any outside agency that has available or published information concerning the charge or arrest should be included in the petition. **There is a \$25.00 fee for each agency included in the petition that does not have a valid email address to transmit the application with notice and the final order to.** The \$25.00 fee will cover the expense of certified mail in lieu of an email address.

The petition should include both the physical (or mailing) address as well as an email address for each agency listed. Texas Code of Criminal Procedure Article 55A.253(b) prohibits a petition from listing any state or local agency more than once OR including multiple contacts and addresses for different divisions with respect to the same state or local agency.
